Dear Camp Billings' families,

After the first summer camp has closed in over 100 years, we need to begin looking forward to the future. Staffing this summer will be a challenge as we will need to rethink what it means to be a CIT from the ground up, while still allowing our oldest campers to experience their final year. Whether you would like to remain a camper or hopefully join us on staff, we hope to clarify how you should go about coming back to camp.

Step 1: Figure out which category you (or your child) fit into **as of June 2021:**

A) 15 years old and/or going into 10th grade = Eligible to be a camper only → No need to take any further steps besides to contact the Registrar on time.
B) 16 and/or going into 11th grade = Eligible to be a camper AND/OR eligible to apply to be a CIT* ***FILL OUT THE FORM BELOW
C) 17 and/or going into 12th grade = Eligible only to apply to be a CIT ***FILL OUT THE FORM BELOW
D) 18 and/or graduated High School = Eligible to apply for Sr. Staff ***FILL OUT THE FORM BELOW

*Applicable ONLY this year.

Our decisions will be sent out to all applicants BY NOVEMBER 30 -- if you are not accepted as a CIT, you will still be able to register starting on December 1.

Please note, once you've filled out the form, we'll be sending you the applications by the end of the day on November 1. If you haven't received your application by the Morning of November 2nd please contact us via our email (directors@campbillings.org) and we'll send one to you immediately, but please refrain from emailing before then.
